

## Purpose

This performance monitoring report calculates the percent of Sociocultural Effects (SCE) Evaluation results submitted for ETDM projects during Planning and Programming Screens. It is used to determine whether the SCE Evaluation is being conducted during the ETDM Process as expected.

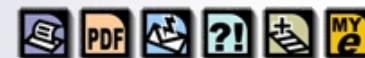
## Instructions

Open the **SCE Evaluation Participation Report** from the left-side menu under **Reports > Performance Management > Performance Monitoring**. The report looks at published summary reports and counts the number of Degrees of Effect submitted during the screening event and the number of Summary Degrees of Effect included in the Summary Report for each of the six SCE issues.

Search Projects

1. Use the **Phase** pull-down menu, and then select **All**, **Planning**, or **Programming**.
2. Use the **Planning Organization** pull-down menu, and then select **All**, **District**, or **Turnpike**.
3. Type the **Date Range** in the **From** and **To** fields, or you can click the calendar icon, , to select the dates when the summary reports were published.
4. Click **Search Projects** to view the report.

## Reviewing the results

For each project with a published summary report, the performance results are displayed in three sections:

- ❖ **Summary of SCE Issues Reviewed** – Displays the number of Degrees of Effect (DOE) and Summary Degrees of Effect (SDOE) submitted for SCE issues
- ❖ **Summary Percentage of SCE Issues Reviewed** – Calculates of the percent of DOEs and SDOEs submitted
- ❖ **Details (by Phase) of the SCE Reviews submitted** – Lists the alternatives included in the summary report and indicates whether the DOE and SDOE were submitted
