<b>Approval of above selections requested.</b> Provide justification/explanation of the requested action:  The Agency Funding and Operating Agreement (AOFA) between USFWS, Florida Department of Transportation (FDOT), and Federal Highway Administration (FHWA), which became effective May 1, 2015, which was subsequently amended to remove FHWA, is requesting a No-Cost Time Extension until December 1, 2020.				
<b>Section 9.A Financial Statement:</b> FDOT shall provide USFWS, subject to appropriation and the advance payment provisions below (Section 9, items C and E), an annual allocation of \$767,577.80 not to exceed a total sum of \$3,837,889.00 over a 5 year 6 month period as reflected in the schedule shown in Appendix C, attached and incorporated herein, ending on , December 1, 2020 or 5 years 6 months from the date of signature, whichever comes later. This sum is based upon the parties' best estimate of the minimum funding required by USFWS to participate in the ETDM Process. If it becomes apparent that there is incongruence between the funding amount established in this AOFA and the services requested to be performed, the parties agree in good faith to renegotiate the level of funding, subject to appropriation, level of service, and/or prioritize project reviews.				
<b>Section 10.A Period of Performance and Evaluation:</b> The term of this AOFA shall commence upon signature or May 1, 2015, whichever comes later and end on December 1, 2020, or five (5) years (6) months from date of signature, whichever comes later, unless terminated sooner in accordance with Section 10(B) below. The payment for associated work shall be inclusive of all work performed up to and including the date of expiration or termination. 
