<b>Approval of above selections requested.</b> Provide justification/explanation of the requested action: <p>This is a six (6) month "no-cost" time extension to allow for the additional time needed to complete negotiations of the new agreement. No additional funds are necessary to support the services currently performed under the current agreement.</p> <p><b>Section 9, Paragraph A</b>, which authorizes the reimbursement to USEPA for a five (5) year term, is amended to read, FDOT shall provide USEPA, subject to appropriation and the advance payment provisions enumerated below (Section 9, items 3 and 5), an annual allocation of \$350,000.00 and a total sum not to exceed \$1,750,000.00 according to the schedule shown in and ending on <b>December 14, 2021</b> or 5 years from the date of signature, whichever comes later. This sum is based upon the parties' best estimate of the minimum funding required by USEPA to participate in the ETDM process. If it becomes apparent that the funding amount established in this AOFA is inadequate for the services requested to be performed, the parties agree in good faith to renegotiate the level of funding and service or prioritize project reviews.</p> <p><b>Section 10, Paragraph A</b>, is amended to read, the term of this AOFA shall commence upon signature or January 23, 2015, whichever comes later and end on <b>December 14, 2021</b>, unless terminated sooner in accordance with Section 10(B) below. The payment for associated work shall be inclusive of all work performed up to and including the date of expiration or termination.</p>
