Approval of above selections requested. Provide justification/explanation of the requested action: This is a one (1) year "no-cost" time extension. No additional funds are necessary to support the services performed under this agreement modification. This amendment intends to allow SRWMD additional time to continue to participate in the Environmental Transportation Decision Making (ETDM) process, provide expedited review, and provide technical assistance to the Florida Department of Transportation (FDOT) Office of Environmental Management (OEM). Article II, Paragraph C , which authorizes reimbursement to SRWMD for a five (5) year term, is amended to read "FDOT shall furnish to the District a total sum not to exceed \$340,884.50 over a period of sixteen (16) years, subject to the payment provision of Article IID. This sum is based upon the parties' best estimate of the minimum funding required by the District to provide supplemental environmental review services for FDOT projects. The funding amount is acknowledged to be an initial funding level and in the event that the level of supplemental services needed becomes greater or less than the initial funding level, the parties agree in good faith to renegotiate the level of funding or services. The ETDM services provided under this Agreement shall terminate on the date specified in Article III, but the payment for associated work shall be inclusive of all work performed up to and including the date of termination. Article III, Paragraph A , which limits the term to five (5) years commencing October 1, 2006, unless terminated sooner in accordance with Article III.B, is amended to read "The term of this FA shall run for a period, commencing October 1, 2006, whichever comes later and ending September 30, 2022 or sixteen (16) years thereafter, whichever comes later, unless terminated sooner in accordance with Article III, Paragraph B. The intent of this modification is to authorize and maintain services supporting this contract through September 30, 2022.
