ETDM Team Outreach

- US 92 from Nova Rd. to US 1 in Volusia County
- Sent one Planning Screen Project to ETAT for Review;
 - SR 19 from CR 48 to CR 561 in Lake County
- After final ETAT review reminder was sent for SR 19 project, the District initiated calls to several ETAT members who had yet to respond within the last week of the review. One outcome of the calling included an individual being reminded to get his draft comments back from someone else within his agency so he could input them in the EST before the deadline. Another ETAT member, from FTA, let us know that he had looked at the project information but had no comment; which will be noted in the Summary Report. He also requested an EST refresher course.
- Completed Planning Summary Reports for the following projects;
 - US 441 from Orange County Line to CR 44B in Lake County
 - US 441 from CR 42 to CR 475 in Marion County
 - SR 46 from SR 415 to Volusia County Line in Seminole County
- Completed Programming Summary Reports for the following projects;
 - SR 46 from Mellonville Ave. to SR 415 in Seminole County
 - US 17/92 from Shepherd Rd. to Lake Mary Blvd. in Seminole County
- Developed and sent invitations for District ETAT meeting scheduled for August 3 & 4 in Cocoa Beach.
- First D5 ETDM Newsletter finalized and mailed 5/19. Next newsletter send date is August.
- Selected consultants for the District's two major ETDM contracts: one for support services, the other for technical studies.
- Met with Volusia County MPO director and MPO ETDM Coordinator to discuss possible projects and schedule from their Cost Feasible List update for uploading into the EST. With changes in funding policy they said they would have one new project on their list, and this project has already gone through PD&E. Since this MPO had anticipated more Cost Feasible projects for screening than any other MPO in our district (around 100 originally), this news came as quite a surprise.
- Coordinated with METROPLAN Orlando (MPO covering Orange, Osceola, and Seminole counties) to aide them in their first MPO-initiated EST screening to take place in fall of '05.
- Sixteen new potential projects were slated for ETDM Screening over the next year. Local funding availability to match TRIP funds will help to determine the consideration of these projects; therefore a screening schedule is still tentative at this point.
- SCE updates:
 - Coordination with MPO liaisons ongoing regarding local government coordination.
 - East Central Florida Regional Planning Council & consultant completed update of six SCE data layers for Volusia County. Data layers and metadata were sent in standard format to GeoPlan for uploading to the EST. Goal is to have updates ready in the EST before two Daytona projects are sent to ETAT late summer '05.
