- Working on Description and Purpose and Need for 6 advanced SIS projects for entry into EST and ETAT review.
- Standardized Primavera scheduling template for ETDM Project Development completed.
- Conference call held with Martin County to discuss ETDM and EST.

## District 5

- Completing data collection and coordination efforts for five future projects:
  - SR 50 re-alignment from SR 50 West merge to SR 33 in Lake County (Planning Scrn.)
  - SR 430 from SR 483 to Seabreeze Bridge in Volusia County (Planning Scrn.)
  - US 92 from Nova Rd. to US 1 in Volusia County (Planning Scrn.)
  - Black Branch Creek in Flagler County (Programming Scrn.)
  - Sharpes ferry Bridge in Marion County (Programming Scrn.)
- Sent one Planning Screen Project to ETAT for Review:
  - SR 50 widening from SR 33 to Bloxham Ave. in Lake County
- Completed Planning Summary Reports for the following projects:
  - SR 19 from SR 48 to SR 561 in Lake County
  - John Young Pkwy. from Portage St. to pleasant Hill Rd. in Osceola County
- Completed Programming Summary Reports for the following projects:
  - I-95 from Brevard Co. Line to Us 92 in Volusia County
  - I-95 from SR 50 to Volusia Co. Line in Brevard County
- Coordinated with newly-formed Lake-Sumter MPO and their consultant regarding screening alternatives for their Cost Feasible adoption (Dec. '05). Further discussion prompted plan of running a GIS analysis on all alternatives, and possibly following up with a Planning screening on a couple projects before the CF adoption date. They will continue to screen all projects throughout the next year or two, but spread them out by only sending a couple of projects at a time. Note--Lake-Sumter MPO is the only MPO in D5 using the EST to help in any Cost Feasible determination for the '05 adoption.
- Met with MPO ETDM Coordinator of METROPLAN ORLANDO (Central Florida tri-county MPO) and gave follow-up training on uploading project information to the EST. Coordinating w/ METROPLAN to send Maitland Blvd. project through a Programming Screening late Oct./early Nov. This will be the first project initiated by any of D5's MPOs. Close coordination and assistance will continue throughout this effort.
- Hosted first District 5 ETAT meeting August 3 & 4. Tentative data for next meeting is in early '06.
- Sent out D5's second ETDM Newsletter on 8/31.
- Issued initial work orders for the District's two major ETDM contracts. Some tasks include compilation of local historical sites, assistance in completion of EST summary reports, pre-PD&E technical studies, project data coordination, Public Involvement assistance, technical assistance to MPOs and FDOT staff, and evaluation of historical and deficient bridges.
- Using MPO liaisons as source for contacts in local government coordination. D5's Project Diary (on cfgis.org) was used to house project info from the EST for local

governments to view. Any comments were either coordinated into project info sent for ETAT review (if received in time) or included in that project's summary report.

- Coordinating with MPO liaison for METROPLAN ORLANDO to give presentation for MPO's next CAC meeting titled "Introduction to the FDOT Efficient Transportation Decision-Making Process and the Role of the CAC" for Oct. 26. The MPO's future Maitland Blvd. project will be presented, and the CAC members will be encouraged to bring back any comments to the following month's meeting. These comments will be incorporated into the project's EST Summary Report.
