District 1

Native American Coordination

- Distributed final District One ETDM Native American Coordination Process for the Miccosukee Tribe of Indians.

ETDM Pre-Screening Activities

- Finalized District One ETDM Pre-Screening Public Outreach Approach/Public Input Summary Guidance. These are methodologies used to standardize prescreening activities such as field reviews, data gathering, and community coordination.
- Conducted pre-screening field reviews for 10 projects in Charlotte, Manatee, Sarasota, Lee, Polk and Collier counties.
- Coordinated with GeoPlan for upload of field data collected on the pre-screening reviews to the EST.

The objective of this collaborative process is to identify needs, clarify issues, and develop strategies that result a win-win scenario for all involved.

 DEIS.
