Identified Opportunities and Challenges

<ul style="list-style-type: none"> During the 2005 Annual Review Meeting USFWS stated that they would like to have more proactive coordination with the districts prior to EST involvement. (Annual Report) The USFWS has experienced minor problems due to a lack of communication between the USFWS, the FDOT, FDOT consultants. (Annual Report) The USFWS transportation biologist positions were not fully funded during the first Funding Agreement, therefore a budget shortfall occurred in the areas of salary and benefits for the 3 transportation biologists. 	<ul style="list-style-type: none"> The Central Environmental Management Office (CEMO) has coordinated with the District ETDM Coordinators and asked that the districts talk with USFWS to increase coordination efforts. Additionally, FDOT is working to have a schedule of projects placed in the EST. The CEMO has communicated the need for increased communication and coordination with the District ETDM Coordinators. The increased communication between USFWS and FDOT consultants will result in maximized efficiencies during the review process. FDOT developed an Exhibit A to consolidate

- (Annual Report) USFWS has indicated that they have not been receiving notification of FDOT project summary reports.
 - (Annual Report) USFWS discussed travel for training being needed even if not directly related to ETDM because it would help make the ETDM reviewers more efficient at their jobs.
 - (FDOT Comptrollers Office) Timely Advance Pay request and Expenditure Reporting
 - (USFWS Project Report) The USFWS has requested a Lump Advance Payment Agreement.
 - (USFWS Project Report) USFWS has experienced invoice processing delays
- expense categories and provided additional funding flexibility. Additionally, the USFWS was allowed to utilize the remaining balance of expense funds to pay salary and benefits accrued.
 - The EST is currently set up to provide an email notification to all ETAT members once a summary report has been completed.
 - FDOT and FHWA have made a policy decision that ETDM training, PD&E training or training in the agency representative's area of expertise to support the FDOT funded position's knowledge and expertise are acceptable. Attendance at professional development activities for the funded position is limited to attendance at no more than one or two professional development meetings, workshops and/or national conferences per year. One ETAT funded position may attend the conference, workshop or meeting to represent the agency; and would provide a "Report" for information sharing to the agency and FDOT for their program files. Additionally, all out of state travel must have prior FDOT approval.
 - We have been requested by the FDOT Comptrollers Office to maintain timely Program and Project Reporting and Expenditure Reporting (including submittal of documentation for expenditures) in order for FDOT to seek federal reimbursement.
 - FDOT discussed the USFWS request for Lump Sum Annual payment in 2005. This would entail USFWS depositing the funds provided by FDOT into an interest-bearing account and return all interest earned on the account to FDOT at the end of the period of performance. USFWS has stated that this is contrary to federal policy and rules. Additionally, the FDOT Comptroller indicated that use of Lump Sum Annual payment is not acceptable and that the USFWS should maintain quarterly payment.
 - Upon receipt of a final invoice or Advance Payment request, FDOT hand delivers the request to the Disbursement Office for payment. FDOT also monitors the payment request to ensure that payment has been made to the USFWS. FDOT is also dependent on USFWS to notify them if

payment has not been received. The last two invoices (numbers two and three) were received by FDOT and paid within one week.
